DELIGHTFUL DIVERSIONS hopes to create a fun and interactive atmosphere to the Park Place Mall in unique and interesting ways. Selected performers/performance and not for profit groups will receive a small per-performance stipend (approximately \$20 per location per group) to perform at one of the designated locations and also have the opportunity to busk (collect money via hat, instrument case, etc.).

Street Performers

Performances can be just about anything that people find entertaining. Entertainers may do acrobatics, animal tricks, face painting, balloon twisting, card tricks, clowning, comedy, contortions & escapes, dance, juggling, magic, mime and a mime variation where the artist performs as a living statue, puppeteering, storytelling or recite poetry or prose and even street theatre.

Musicians

Seeking professional and amateur musicians to play acoustic music in designated locations both inside and outside the mall. If you can play guitar, sing a little, or play some other instrument, you might be able to be a street musician. Earn a few bucks. Sharpen your performance skills. Feed your inner rock star.

Artists

Seeking professional and amateur artists for live art demonstrations, including, but not limited to jewelry making, oil and watercolor art, pottery demonstrations, calligraphy, cartoonist, or glass blowing. Artists are encouraged to bring a few samples of their art for sale, as well as interacting with the crowd to discuss their process through demonstrations. Artists that specialize in children’s arts and crafts activities are also encouraged to apply.

Non Profit

Seeking not for profit organizations interested in promoting awareness for their cause through creative and interesting avenues. Not for profit organizations dedicated to all worth while causes are encouraged to apply for a table space to promote their organization with children friendly activities. Non Profits will be placed near the children’s indoor play land in Park Place Mall to conduct awareness for their cause with interactive activities targeted to ages 3-12, parents and families in interesting and creative ways. Example: Instrument Petting Zoo for Children and Parents, Health Based Advocacy through educational activities, Music Instruction, or any other creative means to promote your cause and organizational mission.

SAACA and General Growth Properties will be promoting the Series through posters, email, press releases, radio promotions, website, Facebook, Twitter and more.

All applicants will be selected through an application process, which includes a review of performance Via application description, and if available, website, video, CD, or live auditions. In addition, all applicants are required to follow the conduct guidelines set forward by the Southern Arizona Arts & Cultural Alliance and General Growth Properties. Additional restrictions require that minors between the age of 15-17 years of age will be allowed to perform without an adult. If younger than 15 adult must be present. If younger than 18, permit is required to be issued in parent/guardian’s name.
